

## Don't miss RIA's Devolution Week!

March 2, 2021



In 2021, devolved nations and regions across the UK will go to the polls to elect Members of the Scottish Parliament (MSPs) in Scotland, Assembly Members (AMs) in London, Members of the Senedd (MS) in Wales, and Mayors in London, the Midlands and the North.

All next week, from 8 to 12 March 2021, the Railway Industry Association (RIA), with partners Northern Rail Industry Leaders, will be delivering a **Devolution Week** to explore the key rail issues facing these devolved nations and regions.

The week will involve a virtual event each day, covering Scotland, London, the Midlands, the North and Wales respectively. Each session will include a panel discussion with leading industry speakers and decision makers from that nation and region, followed by a workshop for the industry to feed into the devolved manifestos RIA will be drafting in the run up to the elections.
